## NAVY ANNOUNCES COMMISSIONING DATE FOR FUTURE USS RICHARD M. MCCOOL, JR.

The Navy has approved the commissioning date for future amphibious transport dock ship USS Richard M. McCool, Jr.

The Navy will commission Richard M. McCool, Jr., Sept. 7, 2024, at Naval Air Station Pensacola in Pensacola, Fla.

The naming of LPD 29 honors Navy Capt. Richard M.

McCool Jr., who was awarded the Medal of Honor in 1945 for the heroism he displayed after his ship was attacked by kamikaze aircraft in the Battle of Okinawa. Despite suffering from shrapnel wounds and painful burns, he led efforts to battle a blazing fire on his ship and rescue injured sailors. LPD 29 will be the first of its name.

Richard M. McCool Jr. is co-sponsored by Shana McCool and Kate Oja, granddaughters of the ship's namesake. As the co-sponsors, McCool and Oja lead the time-honored Navy tradition of giving the order during the ceremony to "man our ship and bring her to life!" At the moment, the commissioning pennant is hoisted and Rich-

ard M. McCool Jr. becomes a proud ship of the fleet.

Richard M. McCool Jr. will be the Navy's 13th San Antonio-class amphibious transport dock ship.

Amphibious transport docks are used to transport and land Marines, their equipment, and supplies by embarked Landing Craft Air Cushion (LCAC) or conventional landing craft and amphibious assault vehicles (AAV) augmented by helicopters or vertical take-off and landing aircraft (MV 22). These ships support amphibious assault, special operations, or expeditionary warfare missions and serve as secondary aviation platforms for amphibious operations.



More than 300 volunteers have signed up to place the flags on Saturday. Rotary District 5340 is seeking volunteers on Tuesday, May 28 at 3 p.m., to help pull the flags and make them ready for Memorial Day 2025. 



## Admiral: Success of Red Sea operations are a tribute to Sailors, systems

Navy vessels have been plying the Red Sea since December as part of Operation Prosperity Guardian, a U.S.-led, multinational coalition established to counter attacks by Houthi terrorists on merchant and naval vessels.

“Our forces are engaged in the Red Sea right now [in a way] we’ve not seen since probably World War II. I mean, those ships are operating inside weapon engagement zones. They have to be prepared on a moment’s notice to conduct engagements, and they have to get it right every single time,” said Navy Rear Adm. Fred Pyle, director of the Surface Warfare Division, at a Center for Strategic and International Studies event May 14.

“I could not be more proud of how those sailors are performing over the last six months and also how the systems are performing, given what they’re operating in,” he said.

They’re engaging enemy antiship cruise and ballistic

missiles, as well as unmanned systems, Pyle said, while also navigating through waters at night where merchant vessels are steaming.

The integrated air- and missile-defense on these ships provides a layered defense distant, close in, and in between, he said, adding that aircraft from USS *Dwight D. Eisenhower* aircraft carrier are also playing a vital role in the mission.

Expensive missiles are being shot at much cheaper drones, the admiral acknowledged.

“Should we find a more cost-effective way of downing say, an inexpensive drone? Absolutely. And we’re working towards that,” he said, adding that there are solutions being considered, but he couldn’t get into more detail because

of the classified nature of that effort.

Allies and partners are a vital part of the effort. More than 24 nations are supporting Operation Prosperity Guardian, he noted.

“It’s always good to have an international face on an effort where you’re trying to maintain the flow of global commerce,” he said.

Many months of training have paid off for this mission, particularly in utilizing virtual, live and constructive simulations, Pyle said.

The admiral said that two key lessons learned from the conflicts in the Red Sea and Ukraine are that the services need to increase their munitions stocks and increase the

means to resupply anywhere in the world.

“We’re very focused on getting our munitions inventories increased,” he said. “We’re in a sustainable position right now, given what we’re seeing in the Red Sea.”

# 'HIGHER STAKES': USS TRUMAN PREPARES FOR RED SEA MISSION TO COUNTER DAILY BARRAGE OF HOUTHII MISSILES AND DRONES

MIAMI - USS Harry S. Truman will soon lead a Navy strike group into the volatile Red Sea, where U.S. Sailors have fought almost daily for months to down drones and missiles launched by Houthi rebels from Yemen.

The nuclear-powered aircraft carrier and its 6,000-some Sailors have spent recent months training in the western Atlantic Ocean for that mission - a rare, pre-planned deployment expected to take the ship into a hostile environment. In recent weeks, its Sailors have been undergoing flight deck testing, its pilots knowing that later this year they will be tasked with shooting down drones and munitions launched by the Iran-backed Houthis.

"They know that they're most likely going to be entering a weapon engagement zone," said Adm. Daryl Caudle, the leader of Navy Fleet Forces Command. "I believe, personally, that puts higher stakes on why what we do [in training] is so important. ... For this group, this [deployment] is not with the mindset that they're just going to go drill holes in the water somewhere — this is, 'We're going to be employed for combat.'"

But with combat on the minds of *Truman's* sailors and preparations being made to deploy to the

hostile waters of the Red Sea, the 1,000-foot-long, 104,000-ton aircraft carrier made a rare appearance in Miami to have the ship's sailors participate recently in the city's first Fleet Week.

**There was some "push-back" from Navy planners, Caudle admitted. An aircraft carrier had never participated in a U.S. Fleet Week anywhere. But when Fleet Week kicked off May 5, Truman sat stoic, anchored just a few miles off the coast of Miami Beach - its Sailors gathered on the flight deck to wave emphatically at their counterparts aboard USS Bataan, as the amphibious assault ship entered Miami's port.**

"I will admit that bringing a nuclear-powered aircraft carrier to a Fleet Week is unique," said Caudle, who is charged with providing trained and ready naval forces to combatant commanders around the world. "And of course ... they're [in the middle of] doing the training ... they need to do to ensure that they're certified and qualified and proficient and ready to go fight. Fleet Week is not built into that."

The crew used the voyage from its home base in Norfolk, Va., to Miami and back - *Truman* recently returned to Norfolk - to conduct extra tactical training at sea, Caudle said. The carrier's time in Miami was largely meant

to give Sailors a fun port call and to interact with the local community, a sort-of recruiting effort that top Navy officials, including Caudle, said they hoped would spark interest in the sea service among more young Miamians.

The admiral said he hoped the Fleet Week stop, wedged into a critical train-up for what would likely be the most dangerous deployment most of the sailors have ever served, would spark memories of their service and bolster their quality of life in the Navy.

"Once they actually come over to the city, and immerse themselves into this incredible town, and get to experience the food, and the people, and the nightlife and all that, that is what builds the memories, and [that is] why people stay in the Navy," Caudle said. "I'm going to be honest; this is what I remember from my almost 40-year career are the places I've pulled into. The operations tend to be a bit of a blur, but you really remember the port calls."

With Fleet Week over, the bulk of *Truman's* preparations begin.

Navy officials declined to say precisely when *Truman* will embark on its cross-Atlantic voyage toward the Red Sea to replace USS *Dwight D. Eisenhower*, which deployed from Norfolk in October. Caudle said

the deployment was still "several months out." *Eisenhower* briefly left the Red Sea last month for the Mediterranean Sea, but it has recently returned to the Red Sea, according to the Navy.

The Navy canceled a planned visit to *Truman* for news reporters during the Miami Fleet Week, and the ship's top leaders were not made available for interviews.

Caudle said he was confident in the ship's ongoing preparations. The Navy was already incorporating "lessons learned" in *Truman* crew's training from *Eisenhower* strike group's fighting with the Houthis.

While the admiral declined to provide specifics about most of those new lessons, he said they are informing the scenarios that *Truman* has faced in its training. As the carrier completes its pre-deployment training, the ship will deal with similar issues that *Eisenhower* and its escort ships have faced in the Red Sea, said Caudle. Those include lessons on some strategies such as where a strike group's ships should be in relation to one another, how its radar systems should be tuned and the decision-making processes on which weapon should be employed against which incoming munition and when.

## Military recruits would not be tested for marijuana under House draft bill

WASHINGTON - New recruits and incoming officers into the military would not have to undergo mandatory cannabis testing under the House's version of an annual must-pass defense policy bill.

The draft of the 2025 National Defense Authorization Act bars the services from requiring an individual to submit to marijuana testing as a condition of enlisting or commissioning.

Rep. Matt Gaetz, R-Fla., attempted to add the provision as an amendment to last year's authorization bill, which sets priorities for the Pentagon, but was unsuccessful. Its inclusion this year was "a collaborative effort," he said May 17.

Supporters of the measure believe it will help the military attract recruits at a time when few young people want to or are eligible to serve.

"I do not believe that prior use of cannabis should exclude Americans from enlisting in the armed forces," Gaetz said last year. "We should embrace

them for stepping up to serve our country."

The military has long maintained a zero-tolerance, marijuana-use policy but has revisited and loosened its rules in recent years as more states legalized the drug.

The Air Force and Space Force began a pilot program in 2022 that allows some recruits who test positive for THC — the main psychoactive component in marijuana — to retake the test after 90 days.

The Army, Navy and Marine Corps also give applicants second chances to take a cannabis test and the Navy announced in February that it will no longer send home recruits who test positive for marijuana upon their arrival at boot camp.

A 2021 Rand Corp. study of the Army's marijuana waiver policies showed recruits who received waivers for testing positive for cannabis or admitting to past drug use "perform no worse" than other Soldiers.

"That should be welcome news in recruiting offices nationwide. More than half of all new recruits come from states where marijuana is now legal, at least for medicinal use," an essay accompanying the study said.

Recreational marijuana is now legal in 24 states — almost half the country — while medical marijuana use is legalized in another 14 states, according to the Pew Research Center.

The use and possession of marijuana remains illegal under federal law but President Joe Biden's administration moved Thursday to downgrade marijuana from the most dangerous and restrictive category of drugs.

"Far too many lives have been

upended because of a failed approach to marijuana, and I'm committed to righting those wrongs," Biden said.

The House Armed Services

Committee is expected to meet next week to discuss the defense authorization legislation. The Senate Armed Services Committee has not yet released its version of the bill.

## SURFOR establishes Unmanned Surface Vessel Squadron (USVRON) Three

**SAN DIEGO** - Commander, Naval Surface Force, U.S. Pacific Fleet (CNSP) established Unmanned Surface Vessel Squadron (USVRON) Three at Naval Amphibious Base Coronado during a ceremony, May 17.

USVRON Three will oversee a fleet of small, unmanned surface vessels (USV) known as Global Autonomous Reconnaissance Craft (GARC).

During the ceremony, Capt. Derek Rader assumed command of the newly established USVRON Three.

“Our Sailors are the essential key for integration of unmanned surface vessels in the Navy and joint construct,” said Rader. “This will be accomplished through experimentation with the fleet testing and doctrine drafted by operators you see today, who embody and execute the warfighting that we need to achieve to enable the full potential of unmanned systems.”

USVs, including the GARCs, will provide additional warfighting capability and capacity to augment the Navy’s traditional combatant force, providing commanders with a greater range of

capabilities and employment options to increase the Fleet’s tactical and strategic advantages. The goal for USVs is to provide the fleet with operations in conjunction with carrier strike

groups, surface action groups, or even independently.

Manufactured by the Maritime Applied Physics Corporation, GARCs are 16-foot USVs

that enable research, testing, and operations that will allow integration throughout the surface, expeditionary, and joint maritime forces.

Warren is considered to be one of the most influential Supreme Court justices and political leaders in the history of the United States.

## USS *Greenville* arrives at new homeport at Naval Base Point Loma

 NAVALBASE POINT LOMA – Los Angeles-class fast-attack submarine USS *Greenville* (SSN 772) and its crew of approximately 155 Sailors arrived at its new homeport here May 20.

*Greenville* is conducting a homeport shift to San Diego following the completion of a 30 month engineered overhaul at Portsmouth Naval Shipyard in Kittery, Maine. Prior to begin-

ning its EOH, *Greenville* was homeported at Joint Base Pearl Harbor-Hickam, Hawaii.

Submarine EOHs are comprehensive maintenance periods, ranging from 24 to 36 months in duration, and are normally conducted near the mid-point of a submarine's service life. The EOH period encompasses necessary repairs, maintenance, equipment modernization and upgrades, and system alterations.

"It's a wonderful feeling to be here in San Diego," said Cmdr. Chad Tella, *Greenville's* commanding officer. "This crew has worked incredibly hard over the course of the last 30 months while *Greenville* was in the shipyard. Over the past month of operations, the crew has demonstrated their professionalism and resilience in safely bringing *Greenville* to our new home. I could not be more proud of each and every crewmember, and I am happy to join the warfighters of Submarine Squadron 11."

*Greenville* will be joining four Los Angeles-class fast-attack submarines already assigned to Submarine Squadron 11. More than half of the Navy's submarine force is based in the Indo-Pacific region due to the area's strategic importance.

Commander, Naval Surface Forces U.S. Pacific Fleet Vice Adm. Brendan McLane delivered the keynote speech at the ceremony.

"With challenging obstacles to overcome, we have put the right team in place at USVRON Three, and I believe we have done just that," McLane said. "The Navy is placing unmanned systems in the hands of 400 of our most talented warfighters to help integrate, scale, experiment, and employ these systems."

USVRON Three will also incorporate the newest rating, the robotics warfare (RW) specialist into their teams. The rating was announced in February by the Chief of Naval Opera-

tions. They will enable Robotic Autonomous System operations and maintenance at the tactical edge and be the subject matter experts for computer vision, mission autonomy, navigation autonomy, data systems, artificial intelligence, and machine learning on the RAS platforms.

USVRON Three will report to Surface Development Group (SURFDEVGRU) One, under the direction of Commodore Shea Thompson.

"There are currently no boundaries, and we have an incredible opportunity to determine what right looks like within our sphere of influence," said Thompson. "And the SURFDEVGRU One and USVRON Three teams are manned by like-minded surface warriors who are making considerable strides in validating small

USV capability while laying out a clear path to achieving full operational capability by a timeframe that matters."

The mission of USVRON Three is to deliver the most formidable, unmanned platforms in the maritime domain. The squadron will be a cornerstone in building the foundational knowledge required to operate and maintain USV and will spearhead the development of TTPs for USV operations and sustainment. USVRON 3's motto is "Victory Through Ferocity."

SURFDEVGRU 1 is responsible for the maintenance, training, and manning oversight for unmanned surface vessels, Zumwalt-class guided missile destroyers, and future USS *Lynndon B. Johnson* (DDG 1002).

# Try, try again, and then try some more

I arrived at the base marina ten minutes late, setting my nerves on edge before crew practice had even started. Little did I know, the smidge of apprehension I felt would amplify into confidence-obliterating anxiety that would render me virtually useless before the day was done.

It was the first practice for the crew of Alliance, a 40-foot J122 offshore racing sailboat co-skipped by two military-connected sailing friends, Mary and Eric. I'd met Mary through the base's Navy Yacht Club, and she'd invited me to be "delivery crew" last year.

As delivery crew, I wouldn't race with Alliance, but I'd help sail the boat to and from race locations. As a sailing novice with lots to learn, this lesser status was fine by me. In fact, I was grateful to be exposed to this respectable group of lifelong sailors at all.

At 57-years-of-age, my goal wasn't to become an expert offshore racer. Realistically, I'd never fully grasp the complexities of navigation, weather, and tactics. My modest aim was to simply be a useful member of the overall crew.

"Hi, I'm Lisa," I said cheerfully to the crew members who were busy doing various tasks on the docked boat. When they looked in my direction, I sensed mild confusion.

"What's that frumpy, middle-aged woman doing on the boat?" their faces seemed to say.

"Delivery crew," I explained with a nervous chuckle, pointing to myself.

The race crew wore scuffed

boots and sailing gear, showing wear and tear from years of races. By contrast, I was decked out in glaringly spotless boots and crispy-new foul weather gear without so much as a smudge, wrinkle or stray thread.

Once aboard, I looked for ways to help, but it quickly became apparent that I couldn't really help without asking for help myself, which kind of defeated

the purpose of helping at all. When I did take a stab at tasks, I often made stupid mistakes, further rattling my nerves.

"You're making this more difficult," Bill, a race crew member, blurted when I attempted to help him pack a spinnaker sail into its designated bag.

My blunders continued that blustery afternoon during practice maneuvers on the Narragansett Bay. I grabbed the wrong line, attached the wrong shackle, tied the wrong knot, forgot where the fairlead was, sheeted in when I should've eased out.

Each time I goofed or got in someone's way, I pivoted and carried on. However, one by one, tiny invisible chinks formed in my self-confidence.

At 6:30 pm, Alliance sailed out of the bay on port tack, fol-

lowing a rhumb line to a point just south of Block Island. The ocean was quite rough, and I was glad that I'd hidden a seasickness patch behind my left ear. I volunteered to wash the dinner dishes, one task I thought I couldn't screw up, but as I worked at the galley sink, the Shepherd's Pie I'd eaten nearly came back up.

I was assigned to first watch, 8:00 pm to midnight, along with Conor and Julija. When I took the helm, Conor pointed out a lighted beacon up ahead "just of the starboard bow." I searched in vane for the light. "The OTHER starboard bow," Conor said flatly.

In the windblown cockpit, my battered self-confidence finally gave way. For the rest of the watch, I clammed up, unable to do or say anything. I'd hit a mental wall. In all my unsuccessful attempts to be useful, I'd rendered myself useLESS.

Chilled to the bone, I huddled in my designated berth after midnight and my paralyzed brain forgot to set an alarm for the 4:00 am watch. My final rookie mistake was waking up an hour late. The entire crew was topside when I appeared in the companionway, as Alliance re-entered the Narragansett Bay.

At home, I convinced myself that I was the laughing stock of the Alliance crew, and that they'd never invite me back. But I received an email from the skippers assigning me to delivery crew after a race the very next weekend. In mustering the courage to try again, I stumbled upon a quote by Henry Ford: "Failure is only the opportunity to begin more intelligently again."

# Star Wars: Season of the Force 2024 at the Disneyland Resort

This year, Star Wars: Season of the Force celebrations run from April 5 to June 2, with "specially themed food, beverages, merchandise and more for a limited time." Expanding upon the Star Wars theme are Star Tours in Tomorrowland with new adventures, and the Star Wars-themed Hyperspace Mountain high-speed roller-coaster.

On selected dates special after-hours, extra-cost, ticketed Star Wars Nites are also offered with additional special entertainment and more.

However, one day of the year in particular is more special than all of the rest, and it is a day that all park guests may enjoy. It is May fourth, the unofficial Star Wars Day, channeling that iconic line from the Star War movies with a play on words: "Let the

Force be with You!" I made the necessary reservation well in advance and then celebrated Star Wars Day at the Disneyland Resort.

As I often do, I rode several of the Star Wars-themed rides, but what I hoped would be the highlight of this special day would be viewing Disneyland's evening fireworks show from a vantage point within Star Wars: Galaxy's Edge, instead of from a vantage point that had a view of Sleeping Beauty's Castle and the projections on the storefronts of Main Street USA.

Thankfully, in official recognition that Star Wars: Galaxy's Edge is another great place to

Hoping for the best, and aware that the weather forecast was favorable, I joined hundreds of my fellow Star Wars fans around the Millennium Falcon in Star Wars: Galaxy's Edge. Many of those present proudly wielded colorful lightsabers, lighting up the night sky. Even more of us celebrated this special day with themed Star Wars clothing and paraphernalia. There was an intense, palpable feeling of excitement as the time for the start of the fireworks grew closer. Finally, the lights dimmed and the spectacular show began.

## SOCIAL SECURITY MATTERS

### Older husband and working wife seek guidance

*Dear Rusty: I am 74 years old, retired and receiving Social Security. My wife will be 65 in January of 2025. Our hope was to start paying off some credit card expense by her receiving SS when she turns 65, however it appears there would be a substantial reduction to her benefits. Her work income is \$37,500 a year, and she wasn't planning on retiring from work at age 65. Because I am 11 years older, we felt it makes sense to use her Social Security as a means to lower our debt. We have \$27,000 in credit card debt, and I don't really want to use my 401(k) funds due to taxes. We pretty much live on my Social Security and pension. Signed: Seeking Suggestions*

**Dear Seeking:** Your wife's full retirement age (FRA) for Social Security purposes is age 67. Because she will not yet have reached her FRA in January 2025 (when she is 65), if she claims SS to start at that time, not only will her monthly amount be reduced, but she will be subject to Social Security's annual earnings test. The earnings test sets a limit for how much can be earned by beneficiaries who claim SS before FRA.

The earnings limit for 2024 is \$22,320. The limit for next year is not yet published (it's based on changes to the national wage index) but will be a bit higher - likely about \$23,500. Thus, I can't provide the exact impact, but if your wife's 2025 earnings exceed next year's limit, Social Security will take back \$1 in benefits for every \$2 over the limit (half of the amount over the limit). So, if your wife earns \$37,500 per year, that will likely be about \$14,000 over the limit and Social Security will take back half of that (\$7,000). They "take back" by withholding future benefits, or you can repay them in a lump sum. So, you will have a choice - repay Social Security from your other assets, or they will withhold your wife's SS benefits for the number of months needed to offset her penalty for exceeding the earnings limit. The number of months they will withhold depends on how much is owed and what your wife's monthly SS benefit is. For example, if your wife's age-65 SS benefit is about average (\$1,900) and her penalty for exceeding the limit is \$7,000, Social Security would withhold your wife's benefit for 4 months to recover the penalty, but she would receive her full benefit for the remaining 8 months of the year.

Unless your wife tells them in advance that she will exceed the limit, Social Security will find out the following year (after you file your income taxes). But, in any case, your wife cannot avoid the annual earnings test for working before reaching her full retirement age. The earnings test goes away when your wife reaches her FRA of 67. Until that time, if she continues working she will have a choice to have her benefits withheld for a portion of the year, or simply repay Social Security in a lump sum (in which case her benefits would continue uninterrupted).

FYI, there is a silver lining in this, because if your wife has benefits withheld because she exceeds the earnings limit before her FRA, after she reaches her full retirement age Social Security will give her time credit for the months when benefits were withheld, which will result in her monthly Social Security payment amount increasing somewhat at her full retirement age. Thus, over time, your wife may recover the benefits which were withheld for exceeding the annual earnings limit. But to get 100% of the benefit she's earned from a lifetime of working, and be exempt from Social Security's earnings limit, she would need to wait until she reaches her FRA to claim.


